# TERMS AND CONDITIONS



## 1. Member Application

Monthly Installment Application Form (including payment terms) must be properly completed. No application will be accepted until clearance of relevant cheques and/or credit card form is completed. Acceptance to membership shall be the sole discretion of the Company.

## 2. Fees

### 2.1 Joining Fees / Start Up Fees

In addition to the subscription fee, you may be subject to a one-off joining fee on the date of acceptance of membership. This is the rate shown in our Membership Tariffs 2018.

### 2.2 Payment Terms

Initial payment comprising joining fee, ~~part payment~~ i.e. prorated subscription fee for joining month, and first monthly subscription fee installment (where applicable) shall be due and payable on the date of acceptance of membership. This initial fee is payable by cash, cheque, card or wire transfer. Thereafter, monthly subscription fee is payable on the first day of each subsequent month. If you opt to pay by your credit card, you must provide the information in STEP 4 above, allowing the Club to charge your card manually on the first day of the month and every month until membership completion date.

### 2.3 ~~Manual Transactions~~ Charges on default

If the member defaults on payment, membership will be suspended immediately and will not be reactivated until total past payments are completed.

The Club has the right to charge an additional BD10 for ~~debt outstanding for over 30 days~~. This will be charged when total past payments are completed.

## 3. Member Charter
